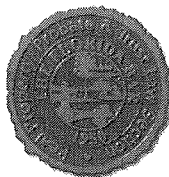

The collection includes one of the few remaining airworthy B-17 Flying Fortresses, the mainstay of the bomber fleet which bombed Germany into submission during WWII; one of the few remaining P-40 Warhawks, of the type flown by the famed Chennault Flying Tigers against the Japanese *before* Pearl Harbor; a Corsair, the gull wing fighter flown by the Boyington's Black Sheep Squadron, a P-51C with its 1500 HP Packard engine capable of a top speed of 434 MPH, of the type flown by the Tuskegee Airmen, the famous all black squadron during WWII that never lost a bomber they were escorting to enemy aircraft. As their reputation grew, bomber crews, putting aside racial prejudices of the time in favor of self protection, would request the "redtails" as escorts. Then throw in a Mitsubisi Zero, the famous Japanese fighter in the Pacific; a B26 of the type used by Doolittle's raiders on the first raid on mainland Japan in the spring of 1942 launched from the USS Hornet; a Supermarine Spitfire MK16 that

fought off the German Messerschmitts and Focke-Wulfs during the Battle of Britain, and a Ford Trimotor, a 1926 airliner of the day. When I was there last, they were rebuilding a MIG 15 flown at the beginning of the Korean Conflict. You could walk up to the parts bin and look in. There are too many more to mention.

As if this wasn't enough, we will have use of the flight simulator, in case you've never before flown a Corsair. The instructor will caution you to keep the left wing up on landing to avoid contact with the ground and the nasty resulting ground-looping characteristics the Corsair was known for.

You can tell from my enthusiasm that I'm really looking forward to this outing and I'm sure you'll enjoy it too. I emphasize – bring the kids.

We'll have a catered dinner and private closed museum tour of this facility on Saturday evening. The cost of this \$230-per-head-event is absorbed substantially by our friendly sponsors so the cost to you is \$125, beginning with a reception and including a fillet of beef and grouper premium dinner in the officer's club. And about my suggestion to bring the kids – for kids 12 and under, the price is \$25 and with that they get a kid's meal, chicken fingers, fries, and the usual. We're also working on a kids pricing for Friday night which should be around the same price or a little more, with a similar menu, probably burgers and fries, etc.

In between all this opulence and excitement, we expect to have the usual full schedule of committee meetings, round table breakfasts and our executive council meeting. I expect to have a report from our special committee appointed to determine procedures for considering requests for new appointments to the executive council.

Of course, there are the golf facilities which abound and the various theme parks for the kids. Remember it is Yom Kippur on the following Monday and many courts and offices throughout Florida are closed, offering you the perfect opportunity to take an additional day as a well-deserved vacation.

After you're duly impressed by the Gaylord Palms, multiply that by a factor of 3 and you've got the Gaylord Grand Ole Opry Hotel in Nashville, the next stop on our tour. I won't tell you now all the events planned for that venue, but I can tell you that some of the premier events are an early show at the original Grand Ole Opry (the historic Ryman auditorium which dates from before the civil war), followed by a night of bar-hopping historic C&W bars with Fletcher as tour guide, a night at the current Grand Ole Opry House with the Rockettes performing their Christmas Spectacular, and a dinner and a show on the world's largest paddle wheel showboat, the General Jackson. More information on this later.

We always say, make your reservations early. If you haven't done so, I suggest you consider doing so now for Nashville, Hutchinson Island and the Convention. In your agenda material is the complete list of the meetings for the balance of this year and also for next year. Of course, all the block rooms are sold out for Kissimmee, but I'll let you in on something I negotiated with the hotels this year. As long as the hotel has available rooms, even if they are sold out of the block rooms, we can reassign our cancellations to a waiting list which Terry maintains. So if you waited too long, and the hotel tells you the block is sold out, check with Terry and he gives preference to EC members to get them the block rate. Most everybody gets in.

Hi kids:

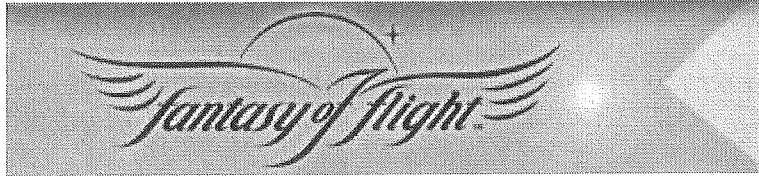

I'll see you all there!

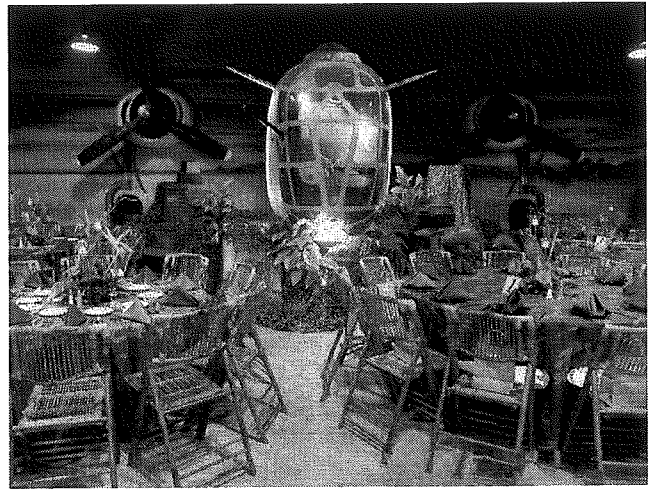
