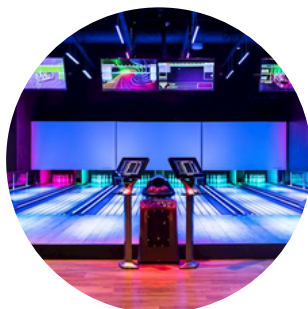

Secretary of State Laurel M. Lee

Secretary of State Laurel M. Lee was appointed by Governor Ron DeSantis as Florida's 36th Secretary of State and began serving in February 2019.

During her tenure as Secretary of State, Secretary Lee has worked to strengthen the state's elections infrastructure and cybersecurity defenses, to increase voter registration and participation, and to ensure accurate, fair, and secure elections in Florida. She is honored to serve as a member of the Florida Women's Suffrage Centennial Commission, celebrating the 100th Anniversary of the Nineteenth Amendment. In addition to her duties as Florida's Chief Elections Officer, Secretary Lee serves as Florida's Chief Cultural Officer, Chief Protocol Officer, and oversees the Divisions of Cultural Affairs, Historical Resources, Corporations, Libraries and Information Services, and the Office of International Affairs.

Secretary Lee previously served as a Circuit Court Judge in Florida's Thirteenth Judicial Circuit in Hillsborough County, Florida. During her time as Circuit Court Judge, Secretary Lee presided in the Circuit Civil Division, the Civil Appellate Division and the Domestic Relations Division. Prior to serving as a Judge, Secretary Lee was an Assistant United States Attorney in the Middle District of Florida. She also previously served as an Assistant Federal Public Defender in the Middle District of Florida, as a federal judicial law clerk, and spent time in private practice.

Secretary Lee received her Bachelor's Degree and a Juris Doctorate from the University of Florida, where she was a member of Florida Blue Key. She was inducted into the University of Florida Hall of Fame in 1999.

2021 RPPTL CONVENTION

Attendee Health Attestation

To do our part in preventing the spread of COVID-19, we are restricting attendance at any of our Executive Council meetings from anyone with knowledge that they have a COVID-19 Infection or have recently been exposed to the virus.

(b) You have not in the last 14 days had any close contact with anyone who is either confirmed or suspected of being infected with COVID-19, including anyone who was experiencing or displaying any of the known symptoms of COVID-19.

(c) You have not in the last 14 days traveled from (1) areas of substantial community spreading requiring quarantine per the Florida Department of Health, or (2) traveled internationally based on the current US State Department Level 4 travel advisory for all international travel due to the global impact of COVID-19.

If you cannot affirm or attest to any of the above on the day of the event, please do not attend. We will gladly provide you with a full refund. There is a risk of COVID-19 exposure in any public place where people are present. COVID-19 is highly contagious and can lead to illness and death. By attending the event, you voluntarily assume all risks related to COVID-19 exposure. Thank you for your cooperation.
