Ms. Rolando also thanked the members of the Legislation Committee, in particular Barry Spivey and Robert Swaine as co-chairs of the Committee for the Section's success during the 2013 legislative session. Ms. Rolando also recognized Peter Dunbar, the Section's Legislative Consultant and the members of his "team" for their outstanding work during the legislative session.

Ms. Rolando noted the 2013 – 2014 RPPTL Section Executive Council meeting schedule and in particular the schedule of events for the Out-of-State Meeting in Lisbon, Portugal.

Ms. Rolando then asked that Executive Council members assist in controlling meeting expenses. She explained contract provisions for guaranteeing a block of rooms and meeting expenses, and the increased costs for cancellations without notice. Ms. Rolando asked that members notify Ms. Sherron immediately if they cancel a room so the room may be offered to the next member on the waiting list.

Ms. Rolando then welcomed Greg Coleman, President-elect of The Florida Bar.

Ms. Rolando reported on the Section's filing of an amicus brief in the Florida Supreme Court in response to the proposed Advisory Opinion filed with Court by The Florida Bar Standing Committee on the Unlicensed Practice of Law relating to certain activities undertaken by community association managers. Ms. Rolando noted that the filing would be discussed during the Condominium and Planned Development Committee report.

Ms. Rolando reported on the Executive Committee's approval of the proposed contract and addendum to contract between the Section and Peter M. Dunbar of the Pennington law firm for legislative consulting services to the Section from September 1, 2013 to August 31, 2015, due to the need to vote on the proposed contract before Florida Board of Governors meeting, which occurred prior to the Section's meeting at the Breakers. Ms. Rolando also reported that the Board of Governors of The Florida Bar approved the contract at its meeting on July 26, 2013.

Ms. Rolando reported on the formation of a new "Childrens Advisory Committee", Steven Goodall chair, to plan and coordinate events for children of members at Executive Council meetings and noted that if any members had children who wanted to participate, the committee was meeting concurrently with the Executive Council meeting.

Ms. Rolando reported the Executive Committee's approval of the Section's position with regards to filing an amicus brief in Fourth District Court of Appeals case of *Ross G. Stone, Appellant v. Nancy Stone and Alma Stone, Appellees*, Case No. 4D11-4541 and noted that Michael Dribin would report on this topic during the Chair-Elect's report.

Lastly, Ms. Rolando introduced the new members of the Executive Council and asked them to stand and be recognized.

V. <u>Chair-Elect's Report</u> — Michael A. Dribin

Mr. Dribin reviewed the Meeting Schedule for 2014-2015, in particular the plans for the out of state meeting in his former hometown of Chicago, IL. Mr. Dribin noted that he will be circulating to Executive Council members options for activities at that meeting and asked that members advise him of their preferences.

Mr. Dribin reported on the action of the Executive Committee in connection with the Section's amicus brief in the Fourth District Court of Appeals case of Ross G. Stone, Appellant v. Nancy Stone and Alma Stone, Appellees, Case No. 4D11-4541, as described on pages 335-355, of the Agenda. Mr. Dribin reported that the Executive Committee met again on July 25, 2013, at the Breakers in Palm Beach and voted to reconsider its previous motion regarding the content of the amicus brief. Mr. Dribin reported that the Executive Committee affirmed the motion it previously approved instructing the Amicus Committee as to the content of the amicus brief to be filed in the Stone case. However, rather than asking the Amicus Committee to brief the waiver of homestead issue at this time, the Executive Committee approved that following language to be inserted in the amicus brief with respect to the waiver of homestead issue:

"We appreciate the opportunity to serve the Court by briefing the issue in its Order dated June 14, 2013. Based on our review of the lower Court's order, we recognize the Court may have additional issues to consider, including the criteria for waiver of homestead rights under the facts of this case. If we can be of service on any additional issues in this case, please contact us."

Mr. Dribin stated that if the appellate court, in response to this statement, asks the Section to brief the homestead waiver issue, the position of the Section as stated in its previous instructions to the Amicus Committee on the waiver of homestead issue will apply. Mr. Dribin reported that the brief is in the process of being drafted.

VI. Liaison with Board of Governors' Report

Mr. Sasso was not present. Ms. Rolando introduced Ramon "Ray" Abadin, a member of The Florida Bar Board of Governors who is exploring running for President of The Florida Bar. Ms. Rolando also acknowledged that Gwyne Young, immediate post-president of The Florida Bar and a member of the RPPTL Section Executive Council was in attendance and "welcomed her back" as a fulltime RPPTL. Mr. Abadin discussed current issues before the Board of Governors including the status of the adoption of model rules concerning trust accounts, and the establishment of the "2016 Commission" that will engage in a thorough evaluation of all Bar functions and services including technology, Bar admissions and pro bono services. He expressed great appreciation for the service performed by the RPPTL Section on behalf of both the members of The Florida Bar and the citizens of Florida.

VII. <u>President of The Florida Bar's Report</u> — Eugene Pettis [invited]

No Report.

VIII. <u>Treasurer's Report</u> — S. Katherine Frazier

Ms. Katherine Frazier reviewed the 2012-13 Financial Summary thru June 30, 2013, located on the Agenda at page 42. Ms. Frazier noted two minor mathematical corrections in the figures on the summary: (i) under general budget category the expenses amount should be \$794,084.00; and (ii) the convention deficit should be \$102,829.00.

Ms. Frazier noted that the Convention ran a deficit, which was anticipated. Ms. Frazier thanked the Section Sponsors and Friends of the Section for their support.

IX. <u>Director of At-Large Member's Report</u> — Debra L. Boje

Ms. Debra Boje, Director of At-Large Members, reported that the At-Large Members are "stepping up the pace" of their activities. They have been working with the Membership, Diversity and Law School Liaison Committees to promote its activities. Lead ALMs in the circuits have been sending email blasts promoting Section CLE Seminars. The ALMs will be sponsoring a reception after the certification seminars in Orlando. ALMs are also improving communication with out-of-state members and engaging in outreach to judges in their circuits. Ms. Boje asked for assistance from the Executive Council, especially by forwarding to her information pertaining to legislation, case law or procedural matters that may be of interest to the judiciary.

X. <u>CLE Seminar Coordination Report</u> — CLE Seminar Coordination – Robert Freedman (Real Property) and Tae K. Bronner (Probate & Trust), Co-Chairs

Robert Freedman, Committee Co-Chair, reported that the training session for committee chairs and vice-chairs on Wednesday, July 24, 2013, was a great event and that the materials from that session are posted on the Committee's website. Mr. Freedman emphasized the need to adhere to the deadlines posted for submission of seminar materials. Mr. Freedman noted the CLE schedule in the Supplemental Agenda and also noted that a free E-CLE Seminar on the <u>Koontz</u> environmental permitting case was scheduled for July 31st and over 200 had already signed up.

XI. <u>Probate and Trust Law Division</u> — Deborah P. Goodall, Director

Ms. Deborah Goodall began by noting that the third action item in the Agenda concerning a proposed amendment to F.S. 710.123 (Termination of Guardianship) would not be presented.

Action Items:

1. Ad Hoc Committee on Life Insurance Payable to Revocable Trust – Richard R. Gans, Chair

Mr. Richard Gans, Committee Chair, explained that the motion proposed by the Ad Hoc Committee on Life Insurance payable to Revocable Trust was a fix to the holding in the <u>Morey vs. Everbank</u> decision in order to clarify that a waiver of protection from creditors' claims to certain death benefits must be made with "great specificity". Ms. Gans noted that most practitioners thought the existing statute was already clear on that point and that the proposed amendment was "we really mean it" legislation. Mr. Gans reported that the proposal was unanimously approved at the Probate and Trust Roundtable. Mr. Gans moved:

To adopt as legislative positions of the Section the amendment of F.S. 733.808(4) (death benefits; disposition of proceeds) and F.S. 736.05053(1) (Trustee's duty to pay expenses and obligations of settlor's estate) to clarify that a waiver of the protection from creditors' claims afforded to certain death benefits payable to trusts must be clear and specific, and that a general "pay all claims from the assets of my revocable trust" type waiver is insufficient to waive the statutory protections; to find that such legislative positions are within the purview of the Section; and to expend funds in support of the positions.

The motion was approved unanimously.

2. Estate and Trust Tax Planning – Elaine M. Bucher, Chair

Ms. Goodall reported that the proposed motion from the Estate Trust Tax Planning Committee described on pages 56-156 of the Agenda was discussed at both the Probate and Trust Roundtable and the Real Estate Roundtable and several floor motions to amend the proposed motion would be made based on input received at the Probate and Trust Roundtable. Ms. Goodall requested that the Executive Council waive the rule in Article VIII, Section 4(a) of the Section By-Laws requiring distribution of Agenda items a week prior to Executive Council meetings, which motion as made, seconded and unanimously approved.

Randall Randolf reported on behalf of the Committee and stated that it had looked at Florida's existing public trust company statute and at legislation in various states, including South Dakota, Delaware and Nevada that allow Family Trust Companies. The Committee believed allowing such licensed and unlicensed Family Trust Companies, would simplify matters for such families who would otherwise have to use Florida's complex public trust company statute. It would also enable citizens of Florida to "come back" to Florida rather than forming such Family Trust Companies in other states that currently permit them and that would be of economic benefit to Florida. Ms. Goodall noted that the proposed floor motions to amend the motion described in the Agenda would provide that such companies would not serve as personal representatives or as an agent under Power of Attorney. Mr. Randolf moved:

To adopt as a legislative position of the Section, to allow families to form and operate licensed and unlicensed family trust companies and to authorize out of state licensed family trust companies to operate in Florida, including the creation of new Chapter 659 – Family Trust Companies, the amendment of F.S. 736.0802(2), (3) and (5) (Duty of Loyalty) and F.S. 744.351 (Bond of Guardian); to find that such legislative position is within the purview of the Section; and to expend funds in support of the position.

The motion was approved unanimously.

3. Estate and Trust Tax Planning – Elaine M. Bucher, Chair

[Secretary Note: This item was withdrawn.]

4. Guardianship, Durable Power of Attorney and Advance Directives – Sean W. Kelley, Chair.

Ms. Goodall introduced the action item from the Guardianship, Durable Power of Attorney and Advanced Directives Committee described on pages 163-228 of the Agenda and noted that an amendment thereto had been suggested and approved at the Committee meeting and at the Probate and Trust Roundtable and a floor motion to amend the motion described on the Agenda would be made. Ms. Goodall requested a motion:

To waive the rule in Article VIII, Section 4(a) of the Section By-Laws requiring distribution of Agenda items a week prior to Executive Council meetings concerning the proposal.

The motion was made, seconded and unanimously approved.

Ms. Goodall introduced the Committee Chair, Sean W. Kelley. Mr. Kelley noted that this proposal had been approved by the Section's Executive Council several years ago and explained that there was

opposition to similar legislation proposed in the last legislative session that resulted in the proposal being pulled and that during the Probate and Trust Roundtable it was suggested that the Section's legislative position omit any reference to F.S. 709.2201 to hopefully avoid another battle. Mr. Kelley noted that the proposal would allow access to medical information and the ability to make medical decisions without a finding of incapacity and also provide for healthcare surrogates for minors to make medical decisions for the minor.

Mr. Kelley moved:

To adopt as legislative positions of the Section the amendment of F.S. 743.0645 (other persons who may consent to medical care or treatment of a minor), and F.S. Chapter 765 (Health Care Advance Directives) to provide a competent adult with greater protection in designating individuals to make medical decisions and to allow a parent, legal custodian or legal guardian of a minor the ability to designate a competent adult to serve as the minor's health care surrogate when the parents, legal custodian or legal guardian of the minor cannot be timely contacted by the health care provider; to find that such legislative positions are within the purview of the Section; and to expend funds in support of the positions.

The Motion was approved unanimously.

5. Trust Law Committee – Shane Kelley, Chair

Ms. Goodall introduced the Chair of the Trust Law Committee, Mr. Shane Kelley. Mr. Kelley discussed the proposal described on pages 229-238 of the Agenda and noted that the objective of the proposal is to make the Trust Code antilapse provision more consistent with that of the Probate Code.

Mr. Kelley moved:

To adopt as a legislative position of the Section an amendment to F.S. 736.1106 (Antilapse; survivorship with respect to future interests under terms of intervivos and testamentary trusts; substitute takers) to make the Trust Code's antilapse provisions consistent with the Probate Code's antilapse provisions regarding the treatment of specific devises to certain persons who do not survive the settlor of a revocable trust or the testator of a testamentary trust; to find that such legislative position is within the purview of the Section; and to expend funds in support of the position.

The motion was approved unanimously.

Ms. Goodall then noted that a book was circulating in the meeting room for Executive Council members to send their regards to longtime Executive Council member and former Section Chair John Arthur Jones who is in a rehabilitation facility, allowing members sign their best wishes.

XII. <u>Real Property Law Division</u> — Michael J. Gelfand, Real Property Law Division Director

Mr. Michael Gelfand noted that all action items reflected in the Agenda had been withdrawn for further Committee consideration.

Mr. Gelfand introduced Committee Chair Mr. Steven H. Mezer who thanked the Executive Committee for approving the filing of an amicus brief in the case of *In re: Activities of Community Association* Managers, Supreme Court of Florida Case No. SC13-889. Regarding Proposed Advisory Opinion, FAO #2012-2, Activities of Community Association Managers, in which the Court will determine whether certain functions currently performed by community association managers constitute the unauthorized practice of law.

XIII. General Standing Committees — Michael A. Dribin, Director and Chair-Elect

Action Item:

1. Budget Committee – S. Katherine Frazier, Chair

Mr. Dribin introduced Budget Committee Chair, Ms. S. Katherine Frazier. Ms. Frazier noted that the Section Executive Council currently has two members, Brenda B. Ezell and Tattiana Brenes-Stahl; who have been accepted into The Florida Bar Leadership Academy. Ms. Frazier introduced the following Committee motion as reported in the Supplemental Agenda:

To approve an amendment to the RPPTL Section budget for 2013-2014, to provide for reimbursement of up to \$3500 to each of the Section's two participants (total not to exceed \$7000) in The Florida Bar Leadership Academy for out-of-pocket travel and hotel expenses incurred in attending the Leadership Academy, in furtherance of the motion approved by the Executive Council at its meeting in Tallahassee, Florida, on February 9, 2013 pertaining to the Section's participation in the Leadership Academy.

The motion was approved unanimously.

Information Items:

1. Legislation Committee – Robert Swaine and William T. Hennessey, III (Probate and Trust), Co-Chairs

Mr. Michael Dribin introduced Robert Swaine, Co-Chair of the Legislation Committee who briefly

discussed the renewal of the contract between the Section and Peter M. Dunbar of the law firm of Pennington, P.A. for the rendering of legislative consulting services to the Section from September 1, 2013 to August 31, 2015. Mr. Swaine noted that, as Ms. Rolando stated in her Chair's report, the Executive Committee had already approved the new contract on behalf of the Section due to the need for Section approval prior to the latest Board of Governors' meeting.

2. Ad Hoc Trust Account Committee – John B. Neukamm and Jerry E. Aron, Co-Chairs

Mr. Dribin introduced Committee Co-Chair John Neukamm who reported on the status of the Section's efforts to secure the issuance of an ethics opinion from The Florida Bar's Professional Ethics Committee which would confirm the Section's existing position (as enunciated in the Professional Ethics Committee's Advisory Opinion 93-5 and mandated in F.S. §626.8473(8)) that an attorney may continue to permits a title underwriter to audit a special trust account used exclusively for transactions in which the attorney acts as a title or real estate settlement agent without obtaining informed client consent pursuant to Exception (c)(1) to Rule 4-1.6 (which permits an attorney to reveal information to the extent reasonably necessary to serve the client's interests). Mr. Neukamm noted the background of this issue relates back to a 1994 Bar ethics advisory opinion on trust account management. Mr. Neukamm noted that the issue was discussed extensively at the Real Estate Roundtable and the consensus was that, if the rule currently proposed by The Florida Bar's Professional Ethics Committee, which would leave it to the discretion of an individual attorney to decide if an audit of the special trust account used exclusively for transactions in which the attorney acts as a title or real estate agent is in the best interest of the client, then the "bad apples" in the Bar would use the rule as a shield to prevent an audit. Mr. Neukamm urged Executive Council members to discuss the proposed opinion with members of the Professional Ethics Committee and with Board of Governors members and express the Section's position that the right to audit is in the best interest of clients. Mr. Neukamm stated that the Committee will be developing and emailing "talking points" to Executive Council members for that purpose.

Mr. Neukamm also reported on the recent <u>The Florida Bar v. Roth</u> and <u>The Florida Bar v. Rousso</u> trust account cases in which the Supreme Court imposed a number of requirements on law firms that incur a shortfall in their trust accounts that the Committee perceives to be cumbersome and impractical. Mr. Neukamm reported that the Committee will be studying those opinions and preparing a response. Mr. Neukamm noted that these cases were discussed in detail by Mr. Jim Robbins in his presentation at the Legislative Update Seminar the previous day.

3. Professionalism and Ethics Committee – Lawrence J. Miller, Chair

Mr. Larry Miller reported on the recent Florida Supreme Court's corrected opinion approving a Code for Resolving Professionalism Complaints based on a recommendation from its Commission on Professionalism and noted that Florida is one of only three State Bars that have disciplinary processes relating to professionalism issues. Mr. Miller provided background on the evolution of The Florida Bar's efforts to promote and govern professionalism and the creation of the Henry Latimer Center for Professionalism and the Basic Standing Committee on Professionalism. Mr. Miller noted that the Court in its opinion states that professionalism issues are a constant source of complaints. The Code for Resolving Professionalism Complaints represents an effort to avoid professionalism issues from becoming grievance issues. The approval of the Code will be reported in ActionLine and on the Section's website. Mr. Miller also asked members of the Executive Council to forward ethics opinions of interest to Section members for publication.
