Tami F. Tami is also an active member of the Real Property, Probate and Trust Law (RPPTL) Section of The Florida Bar, serving as a member of the Section's Executive Council and vice-chair of the Trust Law and Procedure Committee, as well as a member of other substantive committees. She is a former chair of the Florida Probate Rules Committee. Tami is a frequent lecturer for The Florida Bar and other professional associations. She is also the author of Chapter 10, Practice Under Florida Probate Code, seventh edition (2014).

James J. American expert on the Torrens System of title registration. He has conducted a series of seminars on zoning litigation, environmental law, landlord-tenant and mortgage foreclosures for the Illinois Judicial Conference.

Andrew M. O'Malley - Mr. O'Malley graduated with high honors from the University of Kentucky and received his law degree from Duke University, where he was a member of the Editorial Board of the Duke Law Journal. He has lectured at ABA and Florida Bar seminars on a variety of real property law topics. He is the past-President of The Florida Bar Foundation, a Fellow of the American Bar Foundation, the Director of the Real Estate Division of the Florida Bar Real Property Probate and Trust Section, the recipient of its 2008 Lifetime Professionalism Award and 2009 Service Award, has chaired the land trust committees of The Florida Bar and the American Bar Association and has served as vice-chair of the Partnerships and LLCs committee of the American Bar Association. He was elected to the American College of Real Estate Lawyers and has been selected for inclusion in both Florida Super Lawyers magazine and Florida Trend magazine's "Legal Elite".
