Our out-of-state meeting at Biltmore Estate in Asheville is just around the corner. Although we plan to have a productive meeting and take good care of Section business, the emphasis will be on slowing down and relaxing for a few days in this exquisite self-contained setting.

Our current room reservation count at the Inn on Biltmore Estate is approximately 125. Cecil and his children, Dini Cecil Pickering and William, Jr. The Biltmore's longtime General Counsel and former President of the North Carolina Bar, Jack Stevens, will speak at our Executive Council meeting on Saturday morning, and we are hopeful that Mr. Stevens will be accompanied by George Vanderbilt's great-granddaughter, Dini Cecil Pickering.

The evening highlights of our meeting will be our group Candlelight Christmas Tour of Biltmore House and following reception at the adjacent Italian Gardens on Thursday evening, and the elegant "Diana" reception and dinner on the hill in front of the holiday-decorated Biltmore House and grounds on Saturday evening. Under a very special arrangement with the Biltmore, your payment of the \$125.00 registration fee (per person) for the "Diana" reception and dinner on Saturday evening will also provide you with access to Biltmore House during the day from Wednesday through Sunday, as well as admission to the group Candlelight Tour of Biltmore House (but not to the reception that follows at the Italian Gardens) on Thursday evening at no additional cost.

 - B. River Arts District (serious art/artists, great wall art, and good lunch places).
 - C. Downtown (old; unique; hip; cafes/restaurants (Market Place, Asheville's oldest and reputed best, serving continental food; Limones, serving best margaritas in town; Curate Tapas; and Cuban restaurant in historic Grove Arcade); art; music halls (great music scene on Friday and Saturday evenings). Immediate Past Chair (and World traveler) George also calls our attention to a sort of spontaneous flash-mob type of "Drum Circle" (drumming, dancing and watching) that sometimes occurs from about 6 to 10 on Friday nights downtown in Pritchard Park on Patton Avenue at College Street. However, the Drum Circle appears to be a warm-to-moderate weather sport and may not occur in chilly/cold mid-November.
