 - (A) August 23, 2023: On July 6, 2023, the Florida Supreme Court issued its Corrected Opinion in In Re: Code for Resolving Professionalism Referrals and Amendments to Rule Regulating the Florida Bar 6-10.3. Subsequent to the Section's Executive Council meeting on July 22, 2023, the Professionalism & Ethics Committee prepared a proposed Comment for submission to the Court by the September 19, 2023 deadline. On August 23, 2023, the Executive Committee voted unanimously to seek an extension of time from the Court to allow for the RPPTL Section's full Executive Committee to provide opportunity for discussion and to approve the filing of a Comment on the matter, should the full Executive Committee decide to file one.

The Executive Committee also voted unanimously to direct the Professionalism and Ethics Committee to collaborate with the CLE Committee to present a series of CLEs focused on non-discrimination

- principles and bias recognition and elimination in the substantive context of real property, probate and trust law.
- (B) September 7, 2023: The Executive Committee voted to ask the Florida Supreme Court for an extension of time through December 15, 2023 to provide the Section with an opportunity to discuss, consider and debate whether to comment on the two proposed procedural tracks for changes to the Rules of Civil Procedure being considered by the Court and, if deemed advisable, for the Section to provide a comment.
- (C) <u>September 7, 2023</u>: Consistent with the direction provide by the Executive Council at its July 22, 2023 meeting, the Executive Committee voted unanimously to adopt a legislative position clarifying the common law expressly validating easements, servitudes and other interests in real property notwithstanding that, at the time of creation, all of the affected real property is under common ownership. The Committee found this legislative position to be within the purview of the RPPTL Section and voted to expend funds in support of the proposed legislative position. **p. 33**

General Comments and Recognition of Division Sponsors.

Action Items:

Proposed legislation to update Florida's Uniform Principal and Income Act, which generally follows the new Uniform Fiduciary Income and Principal Act, in order to

achieve greater consistency among state laws, but including certain modifications that reflect Florida public policy choices.

Motion to:

- (A) update Florida's Uniform Principal and Income Act, which generally follows the new Uniform Fiduciary Income and Principal Act, in order to achieve greater consistency among state laws, but including certain modifications that reflect Florida public policy choices;
- (B) find that the legislative position is within the purview of the RPPTL Section; and
- (C) expend funds in support of the proposed legislative position.

Jolyon Acosta presented. Allows for fiduciaries to invest for better return. Seven states have already adopted this uniform act. Unanimously approved.

2. Probate Law and Procedure Committee - Theodore S. Kypreos, Chair

The *Johnson v. Townsend* Fix: Proposed legislation to clarify existing Florida law by statutorily exempting title disputes arising under the Florida Uniform Disposition of Community Property Rights at Death Act ("Act") from Florida's probate creditor claims procedure; creating a new dispute resolution mechanism and 2 year statute of repose specifically designed for title disputes arising under the Act, and making narrowly focused modifications to the Act and other related provisions of the Florida Probate Code to reduce the risk of unintended forfeitures of the property rights the Act is intended to preserve.

Motion to:

- (A) clarify existing Florida law by statutorily exempting title disputes arising under the Florida Uniform Disposition of Community Property Rights at Death Act ("Act") from Florida's probate creditor claims procedure; creating a new dispute resolution mechanism and 2-year statute of repose specifically designed for title disputes arising under the Act, and making narrowly focused modifications to the Act and other related provisions of the Florida Probate Code to reduce the risk of unintended forfeitures of the property rights the Act is intended to preserve;
- (B) find that the legislative position is within the purview of the RPPTL Section; and
- (C) expend funds in support of the proposed legislative position.

Presented by Theo Kypreos & Juan Antunez. Changes were made to

address comments made at the Delray Beach meeting. This is an amendment to the Florida Uniform Disposition of Community Property Rights at Death Act responding to the *Johnson v Townsend* case. The opinion added ambiguity to the statute that needed to be addressed. Juan thanked people from both Section divisions who assisted with this bill. Passed unanimously.

Motion for the RPPTL Section to support the Insurance and Surety Committee's application to the Board of Legal Specialization and Education and The Florida Bar for the creation of a new board certification called "Insurance Coverage Law."

Debbie Crockett and Cary Wright presented. The Committee is asking the Section to endorse their efforts to create the new certification area. Cary explained the process to be followed to achieve this. The Action Item is only for support for this process. Debbie said only two other states have this certification area — Ohio & Texas, although Texas' isn't limited to coverage. The Committee has 198 signatures on the petition, but their goal is 250 signatures. Passed unanimously.

2. <u>Title Insurance and Title Insurance Industry Liaison</u> – *Christopher W. Smart, Chair*

Proposed legislation to amend section 28.223, Florida Statutes, governing Clerks of the Circuit Courts, to ensure the availability of necessary information about deceased individuals contained in the land records maintained by the Clerks so that proper heirs can be identified in the chain of title and protect the public interest of certainty in the ownership of real property.

Motion to:

- (A) amend section 28.223, Florida Statutes, governing Clerks of the Circuit Courts, to ensure the availability of necessary information about deceased individuals contained in the land records maintained by the Clerks so that proper heirs can be identified in the chain of title and protect the public interest of certainty in the ownership of real property;
- (B) find that the legislative position is within the purview of the RPPTL Section: and

(C) expend funds in support of the proposed legislative position.

Chris Smart presented. Court orders are required in probate that affect title, but title examiners need to go to the clerks' offices to examine them, plus some clerks destroy the records after five years, all of which create uncertainty in title to property. Passed unanimously.

3. Real Property Problems Study – Susan K. Spurgeon, Chair

Proposed legislation relating to notice by mail or courier; amending section 1.101 (corrected as stated below), Florida Statutes to: include electronic confirmation; providing retroactive application; providing an effective date.

Motion to:

- (A) amend section 1.101 (corrected as stated below), Florida Statutes to: include electronic confirmation; providing retroactive application; providing an effective date.
- (B) find that the legislative position is within the purview of the RPPTL Section; and
- (C) expend funds in support of the proposed legislative position.

Amber Ashton presented. Requested a friendly amendment to the motion to correct the statute number reference to section 1.01 rather than 1.101. Changes the definition of certified mail to include any overnight courier with a signature confirmation process. Steve Hearn asked if "overnight courier" is a recognized term requiring overnight rather than 2-day delivery. Amber said all you need to do is prove actual notice rather than whether it was overnight or not. "Overnight courier" means someone who offers overnight services, but doesn't require that service be done overnight. Passed unanimously.

Information Items:

1. <u>Title Issues and Standards</u> – Rebecca Wood and Amanda K. Hersem, Co-Chairs.

Amanda Hersem presented. Presentation of a proposed amendment to Standard 00 to remove the masculine pronoun in the recognition of the diversity in the legal community and in the spirit of inclusivity.

Real Property Problems Study Committee - Merger and Easement –
 Colleen Sachs and Jennifer Bloodworth presented. Case law provides that

one cannot grant himself or herself an easement over their own property, which affects condominium associations, commercial shopping centers and others. Those easements are void ab initio as they merge into the property title. A statutory bill has been proposed that owners can create an easement on their own property without merger, unless the owner has separate properties that come back together. The bill doesn't reinstate any interest which has been fully and finally adjudicated as invalid before the bill's effective date. The goal is to present this bill before the Supreme Court rules on upcoming cases about the merger doctrine in this context. This is the heart of how things have been developed in Florida. The version of the bill that was circulated in the supplemental agenda for this meeting has been changed based upon committee meetings at The Breakers. The current copy of the bill is attached hereto.

Michael Gelfand thanked the committee for its hard work and moved that the executive committee be authorized to pass this bill as an Interim Action to expedite Section approval. Unanimously approved.

XII. General Standing Committees Report — John C. Moran, Chair-Elect

Action Item:

1. Ad Hoc Bylaws Committee -- Robert ("Bob") S. Swaine and William ("Bill") T. Hennessey, III, Co-Chairs

Motion to: (A) recommend approval of the proposed amendments to Articles IV, V, and VII of the RPPTL Section's Bylaws; and (B) authorize transmittal to The Florida Bar Board of Governors with a request for the Board's consent.

The proposed amendments were reflected in blackline as an attachment to the meeting agenda. A complete copy of the RPPTL Section's Bylaws is available on the RPPTL Section website: www.rpptl.org.

John Moran presented. The proposed changes tweak the nomination procedure for corporate officers & ALMS to change the time of nominations, reducing the notice period to the members of the Section of the names of nominees from 60 days to 45 days. The changes also authorize moving the slate as a vote for officers and ALMS by deleting the requirement for a written, secret ballot. Members need to be in person for at least two in-state meetings or be deemed to have resigned from the Executive Council. The proposed changes provide some flexibility to allow virtual attendance. There used to be a stated governmental emergency to allow virtual attendance. This change will give the Section Chair the discretion to allow a virtual meeting without a stated governmental emergency. The vote of officers and ALMS at the convention meeting needs to be in person absent an emergency. The Florida Bar made comments a day or so ago to correct semantics that aren't reflected in the motion attached to the agenda. Passed unanimously.

Information Items:

1. Ad Hoc Rules Revisions Committee -- Michael V. Hargett, Thomas M. Karr, J. Richard ("Rich") Caskey, Co-Chairs

Update on Fast Track Report of the Civil Procedure Rules Committee filed July 3, 2023.

Mike Hargett presented. The Big Bar's Civil Rules Committee stated they were going to provide alternatives to the Supreme Court instead of comments, which could impact the Section. The Board of Governors requested the Civil Rules Committee to make one recommendation, which they did in June. The recommendation includes changing Rule 1.280, the initial disclosure rule, to adopt the federal rule 26 initial disclosures rule. The recommendation left intact the exclusion for probate, guardianship & trust law proceedings. We don't know when the Supreme Court is going to act and how much time they will give us to respond, but this Committee is ready to act with assistance when requested.

2. Communications Committee -- Michael V. Hargett, Chair

Update on "microsite" and matters of interest.

Mike Hargett presented. The updated plan is for the microsite to become the part of the Section website that is public facing. A subcommittee, including several past Section chairs, provided comments. Melissa Murphy commented, saying the website will not be perfect, but will be usable by the target audience. She thinks we need to make a decision and get it open, then we can continue refining it thereafter. Mike said we want members to be featured in website photos, but all the photos we have are of members drinking at the bar and not in court, so photos need to be created for this. The website is 12 pages in length when you count all the links. The existing website won't go away, but this microsite will be the face page for the public.

3. Fellows Committee -- Bridget M. Friedman and Terrence L. Harvey, Co-Chairs

Bridget Friedman and Terrence Harvey introduced the new Fellows: John Curtis Wade Cherneski, Danielle N. Clark, Sara Ashley Harmon, and Natasha Selvaraj. There were 50 applicants to fill 4 available spots.

4. Information Technology Committee -- Hardy L. Roberts, III, Chair

Update on matters of interests related to artificial intelligence.

Hardy Roberts presented on Alex Dobrev's work on updating the Section listservs. Hardy sits on the Big Bar's Artificial Intelligence Committee. They are studying the future of Al and how it impacts professionalism and our

practices. CLE will be forthcoming.

5. Professionalism and Ethics Committee -- Andrew B. Sasso, Chair

Update on Florida Supreme Court's July 7, 2023 Opinion In Re: Code for Resolving Professionalism Referrals and Amendments to Rule Regulating The Florida Bar 6-10.3, Case No. SC2023-0884.

Andy Sasso presented on the new Supreme Court decision approving The Florida Bar's recommendation to review professionalism in Florida. Repealed the Code of resolving professionalism complaints and replaced it with professionalism referrals to local professionalism panels. It modified Professionalism Expectations by saying professionalism standards apply to online communications, as well as communications made virtually and in person. The Supreme Court added an additional 2-hour course being created by The Florida Bar which will involve professionalism and will be offered free to lawyers. Our 33-hour CLE requirement per cycle will be reduced to 30 hours. The Supreme Court removed bias elimination from the list of approved course titles that satisfy the five credit hour per cycle requirement of ethics, professionalism, substance abuse and mental health and wellness. The Supreme Court provided a 75-day comment period for the reduction of CLE hours & elimination of the bias elimination requirement.

6. <u>Liaison with Clerks of Circuit Courts</u> -- Laird A. Lile

Update on matters of interest.

Laird Lile presented. Some clerks were looking for witness addresses in documents and refusing to record now rather than waiting until January 1, but that has now been addressed. Participating in the drafting of new rules forms. Laird has been invited to sit on a committee studying whether to recommend to the courts that some judicial circuits within a single district be consolidated.

7. <u>Liaisons with Business Law Section</u> -- Manuel ("Manny") Farach and Gwynne A. Young

Update on Business Law Section initiative regarding UCC Article 12 (i.e., cryptocurrency).

Amber Ashton presented. The Business Law Section has a task force on the cryptocurrency issue. Manny Farach discussed how the Business Law Section works.

8. <u>Liaison with Pro Bono Committee</u> – *Lorna E. Brown-Burton*

Update on matters of interest.

Lorna presented on the Annual Convention meeting on June 21, 2023.

Discussed the Circuit Committee Handbook that is almost ready to go. Discussion greater public access to legal services and how the Committee could facilitate this. Discussed establishing a commission on self-representation. Looking at connecting more individuals in need with attorneys. Discussed what legal aid groups are doing in lower income areas and how to get with lawyers earlier. Considering allowing second year law students being approved as legal service providers. Considering creating a pro bono page on The Florida Bar's website. Council of Judges from around the state will meet three times per year. Will consider at the next meeting whether paralegals can work pro bono and whether lawyers can report the paralegal pro bono participation in the lawyer's annual pro bono reporting.

CREATION OF EASEMENTS, SERVITUDES, AND OTHER MATTERS AFFECTING REAL PROPERTY OWNED BY THE SAME PERSON

I. SUMMARY

This Bill reiterates the longstanding rule in Florida that an owner can create an interest in their own real property notwithstanding that the owner owns all of the affected real property.

Florida has been one of the fastest-growing states in the nation for decades, and has led other states in passing laws, requiring proper planning at all levels of Florida government.1 These include requirements for statewide, regional, county and local planning and comprehensive plans, which implement zoning ordinances, land use restrictions, and development orders through the creation of easements, covenants, restrictions, declarations, and other written instruments establishing servitudes upon real property, which are often imposed while the property owner owns all of the affected real property.

It also common practice to record covenants, prior to the first sale of any portion of the affected property, requiring a planned property owners' association to bear the costs of establishing and maintaining surface water management facilities, drainage and retention areas, roads, parks, environmental areas, and other parts of the planned community.

Recent judicial interpretations, discussed below, have called into question the validity of easements, and by extension any easement, surface water management agreement, utility easement, access easement, parking easement, negative easement, environmental easement, solar easement, other rights in the nature of an easement, servitude, profit, use right, restriction, obligation, condition, reservation, or other covenant, contained in a written instrument, if such is created at a time when all of the real property is in common ownership. These judicial interpretations misapply the doctrine of merger or other common-law rules to invalidate easements, servitudes and other interests that the grantor intended to bind and benefit the property after its division into separately owned estates, but that were granted before such division.

This misapplication of these common law doctrines is contrary to the long-established land planning regime implemented in Florida, would deprive land planners, governments, and real property owners of an important tool long used in implementing planning and development decisions, and would negate the justifiable expectations of real property owners as to their rights and protections, especially when buying in a condominium, planned development, or community association.

II. CURRENT SITUATION

The practice in Florida has long been for a developer of real property planned for sale to create easements, deeds, plats, declarations, covenants, conditions, restrictions, servitudes, or other written instruments creating an interest in the real property before the first parcel is sold.

Recent appellate level cases have held that an easement is void if the dominant and servient estates are owned by the same party at the time the easement is created. These cases include *King v. Roorda*, 335 So. 3d 1001 (Fla. 2d DCA 2023)² and *AFP 103 Corp. v. Common Wealth Trust Services, LLC*, 2023 WL 2146247, (Fla. 3d DCA 2023)³

These cases call into question not only express stand-alone easements granted prior to, but in contemplation of a sale of a portion of the property, but many easements, servitudes, use rights, restrictions, or other covenants such as those routinely contained in recorded plats, declarations of condominium, homeowners' association documents.

Such rulings frustrate the goals of property owners who clearly intended to create an easement or other interest by recording the instruments in question. A broad application of these rulings also has the potential to adversely and unexpectedly impact the buyers of properties in any number of subdivisions, property owners' associations, condominiums and other communities across the state, who bought rightly expecting to have the access, use of parks and common areas and be subject to the community standards spelled out in the recorded instruments governing their communities.

This broad application has the potential to upend decades of land planning under Chapter 380, Florida Statutes (creating the state land planning agency, setting standards for developments of regional impact, and coastal planning) and Chapter 163, Part II, Florida Statutes (mandating county and municipal comprehensive plans) to the extent it was implemented through easements, deeds, plats, declarations, covenants, conditions, restrictions, servitudes, or otherwise at a time when the affected real property was under common ownership.

III. EFFECT OF PROPOSED CHANGES

New section 704.09(1) reiterates and clarifies existing law, and expressly validates the creation of easements, servitudes, or other interests in real property notwithstanding that, at the time of creation, all of the affected real property is under common ownership.

New section 704.09(2) makes clear that this applies to a broad group of rights and interests in land – specifically listing "any easement, surface water management agreement, utility easement, access easement, parking easement, negative easement, environmental easement, solar easement, other rights in the nature of an easement, servitude, profit, use right, restriction,

obligation, condition, reservation, or other covenant, contained in a written instrument" – without regard to the nature of the instrument by which it is created – listing "an easement, deed, plat, declaration, covenant, condition, restriction, servitude, or otherwise."

The bill limits the misapplication of these common law doctrines only as of the time of creation of an easement or other interest. The bill does not alter the application of the doctrine of merger <u>after</u> properties have been reacquired into common ownership, or the ability of the holders of all properties affected to terminate or modify easements, covenants, and reservations in accord with existing law. The bill does not affect the application of the Marketable Record Title Act, statutes of limitation or repose, or other legal doctrines which may have the effect of terminating or limiting interests in real property after initial creation.

The bill is simply a reiteration and clarification of existing law and should be interpreted to validate and preserve previously granted easements, restrictions, and other written covenants and to apply prospectively to prevent questions as to the validity of such interests created after the effective date.

The owners of properties which have been subject to litigation in which final judgments have been rendered and all appeals periods have run prior to the effective date of this bill, have reasonable expectations as to their property rights as established in those cases, even if the ruling may have been in error or inconsistent with this bill. Consistent with *res judicata*, rules of collateral estoppel and the law of the case, section 704.09(3) provides that the bill does not reinstate any interest which has been fully and finally adjudicated as invalid prior to the effective date hereof.

IV. FISCAL IMPACT ON STATE AND LOCAL GOVERNMENTS

There is no direct fiscal impact on state or local governments.

The bill may have an indirect operational benefit by preserving easements, covenants, restrictions and the like which were imposed as part of land planning, comprehensive plans, or development orders, and by avoiding the shifting of the costs of building and maintaining surface water management facilities, drainage and retention areas, roads, parks, environmental areas, and other parts of the planned community away from the designated property owners' associations and potentially back to a government entity.

V. DIRECT IMPACT ON PRIVATE SECTOR

Real property owners are, for the most part, impacted positively by this legislation through having their reasonable expectations met by receiving the benefit of written easements, plats, deeds, declarations, covenants, conditions, restrictions, servitudes, or otherwise.

VI. CONSTITUTIONAL ISSUES

There are no constitutional issues with the clarification of this law.

VII. OTHER INTERESTED PARTIES

None contacted yet.

Section 1. Section 704.09 Florida Statutes is created to read as follows:

704.09. Creation of easements, servitudes, and other matters affecting real property owned by the same owner.-

- (1) The owner of real property may create an easement, servitude, or other interest in the owner's real property, and such easement, servitude, or other interest is valid notwithstanding that the owner owns all of the affected real property.
- (2) Subsection (1) clarifies existing law, and applies to, without limitation, any easement, surface water management agreement, utility easement, access easement, parking easement, negative easement, environmental easement, solar easement, other rights in the nature of an easement, servitude, profit, use right, restriction, obligation, condition, reservation, or other covenant, contained in a written instrument, whether denominated as an easement, deed, plat, declaration, covenant, condition, 18 restriction, servitude, or otherwise.
 - (3) This section shall not reinstate any interest in real property which was the subject of a court proceeding and which has been fully and finally adjudicated as invalid prior to the effective date hereof.
- 23 Section 2. This act shall take effect upon becoming law.
