

On Friday afternoon, spouses and guests are invited to join Kathy at “Chefs on the Loose” for a “hands on” cooking demonstration, and, on Saturday, Liz’s mother will present a jewelry making workshop. Both of these events should be lots of fun!

Our Friday evening cocktail and dinner reception will take place a short trolley ride from the hotel at the exciting Florida Aquarium. With more than 20,000 aquatic plants and animals from Florida and around the world, the Florida Aquarium is recognized as one of the nation’s top aquariums by [TripAdvisor.com](http://TripAdvisor.com) and *Parent’s* magazine. While wandering through the unique exhibits, you’ll follow a “drop” of water from its underground source, through wetlands, bays and beaches, a coral reef and, eventually, to the open sea. In addition to visiting with one another, we’ll also have the opportunity to interact with some of the Aquarium’s residents. Children will also be able to take a break from their parents by participating in the Aquarium’s acclaimed “kid’s program.”

Our Saturday morning Roundtable meetings will commence at 7:30 am, and the Executive Council meeting will begin promptly thereafter at 10:00 am. Complimentary lunches will be provided at no charge to Executive Council members around noon.

Please plan to extend your stay after the Executive Council meeting concludes on Saturday. Boat tours around Old Tampa Bay and up the Hillsborough River will depart from the marina behind the Tampa Convention Center adjacent to the hotel and will be available on a “first-come, first-served” basis (so register early). Others may choose to explore the world’s longest continuous sidewalk along the Bay via Segway (as described in the attachment regarding local attractions) or “on foot.” However, please return to the hotel early enough to participate in the reception and dinner at the new Tampa Bay History Center (which is halfway to the Florida Aquarium along the Tampa Riverwalk), a state-of-the art interactive museum which preserves and teaches the remarkable history of the Tampa Bay area. Dinner that evening will be provided by the world-famous Columbia Restaurant’s café, which is located within the center. Again, children are encouraged to attend, and there will be a separate children’s’ program at the venue.

For those who wish to continue to explore the Tampa Bay area, I will lead a 2-hour canoe trip along the northern portion of the Hillsborough River after brunch on Sunday. We’ll paddle through a portion of the 16,000-acre wildlife preserve teeming with abundant wildlife and nature’s beauty. Since this is a 3-day weekend, you shouldn’t miss this adventure.

Finally, by popular demand (and because I love photography), we’re reprising the Section’s photography contest that was so successful during last year’s Convention. More information regarding that contest is set forth in the attached flyer (so start taking pictures – or review the ones you’ve already taken – you may have a winner).


