If your child is presently enrolled in a La Petite academy at home, you are eligible for their “Passport Program” and any day care is free. (Talk with your local La Petite Academy for details.) The majority of the events are, however, kid friendly and we have included children’s pricing alternatives whenever possible. In addition, Nashville has some fun “kid spots” including a great zoo. HISTORICAL COUNTRY BAR TOUR AND BEER TASTING - This walking reptile caravan will form in front of the Ryman Auditorium at approximately 8:30 immediately following the live performance of the Grand Ole Opry at the Ryman, and will make appropriate stops to taste beer, hear live music, dance, and inhale second hand smoke (fresh and stale) at several old historic bars on lower Broadway and Printers Alley. Venues currently under consideration include Tootsie's Orchid Lounge, Legends Corner, The Stage and Robert's Western World). You only pay for what you drink!

IMPORTANT NOTE: Virtually all of the activities, events and options on Friday afternoon and evening will be in downtown Nashville in close proximity to each other.
